AN IMPORTANT MESSAGE WHICH CONCERNS ALL USPS MEMBERS UTILIZING GPS

A recent FCC decision to allow high-speed internet and cell phone service to use frequencies close to existing GPS radio frequencies could disrupt GPS signals and cause severe interference to a wide range of GPS receivers, including those used by boaters. On January 26, the FCC gave conditional approval to a private company, LightSquared, to build 40,000 ground stations within the U.S. that would transmit high powered signals in the middle of the existing satellite band of frequencies. As part of that conditional approval, FCC required that additional testing and a report be prepared on the service's potential to interfere with the GPS signals. That report was completed on June 30th and raises significant concerns for boaters and other users of GPS. Hello VBPS Members, Associates and Friends,

I'm sure that many of you are aware of this issue as shown above. I felt this subject was important enough to convey the following to the FCC, Rep. Posey, Sen. Nelson, and Sen. Rubio:

As you consider the conditional approval for LightSquared, I write to ask you to preserve the integrity of the nation's GPS system. Last year, the federal government shut down the Loran navigation system, making recreational mariners solely reliant on GPS for all electronic navigation needs. Like so many other GPS users around the country, GPS is now integrated into our daily outings and we look to the FCC to protect the integrity of the GPS signal.

Recently, I was cruising between Ft. Lauderdale and Vero Beach, Florida when a storm front moved in quickly which left me totally closed in so that I could not make out any land mass. I was able to duck into the Lake Worth Inlet (Palm Beach) only because of my GPS system. If this signal had been interfered with, I would have had to stay in the ocean until the storm front cleared which would have put me in harm's way with regard to other larger boats in the vicinity. I urge you not to allow LightSquared to begin a nationwide broadband service right next to the designated radio spectrum used for GPS. Can you imagine the devastating results of this FCC approval with regard to the airline industry as well as small plane pilots and the many thousands of boaters. Please stop this insanity before lives are lost.

Just recently I received the letter below from Bill Posey, U.S Congressman, Representing Florida's 15th District.

Dear Mr. Boarman,

Thank you for contacting me to express your concerns about new technology in the 4G LTE spectrum and your concerns with LightSquared wireless. I appreciate hearing from you. You will be pleased to know that I share your concerns and was joined by a number of my colleagues in writing the Federal Communications Commission to express our concerns about this project.

As you know, in January the FCC granted permission to offer wholesale broadband via its satellite and base station networks to a wide variety of mobile broadband partners, one of these being LightSquared. LightSquared is a mobile satellite service (MSS) provider with two space vessels that cover North America. These systems operate in the 1.5-1.6 GHz zone, part of what the FCC calls the L-Band. In November of 2010 the company applied to the Commission for more expansive rules that would allow it greater leeway to transmit satellite broadband signals to its "Ancillary Terrestrial Component" (ATC), sometimes referred to as Ground Based Systems. One apprehension is that LightSquared's L Band frequencies may broadcast close to the Global Positioning System (GPS) bands, and there have been concerns within the FCC and commercial GPS users about this possible interference.

Because of these concerns, the FCC instructed LightSquared to convene a study group addressing the interference concerns regarding GPS before LightSquared commences offering commercial service pursuant to a waiver on its L-band MSS frequencies. LightSquared cannot commence commercial operations of its terrestrial network until the FCC concludes that harmful interference concerns have resolved.

Rest assured, I will continue to work with my colleagues on this issue. I am very concerned about the import of this initiative. The concerns that you have expressed have also been conveyed by both the Department of Defense as well as the Department of Transportation because of the possible detrimental effects that these signals could have on commercial GPS systems.

Thank you again, Robert, for contacting me. I appreciate having the benefit of your views. It is an honor to serve you in Congress. 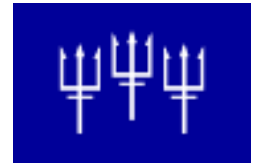
